A. Oral Communications:

1. <u>Brief reports from Directors on matters related to the District, including attendance at city or community meetings</u>

Miller reported on a recent El Cerrito City Council meeting. He said the Redevelopment Agency adopted a resolution stating it is in El Cerrito's best interest for parcels in the Moeser Lane Shopping Center to be assembled and developed by a master developer as a unified development. They plan to issue solicitations for master development proposals. He said that Safeway plans to move out of the center in 2012.

Humphrey said that Ben Reyes had prepared the memo regarding Prop 26 impacts on local governments and could speak about it when he is present at the next meeting.

Manager's Report:

- Stege Administrative Order (AO) from Environmental Protection Agency
 (EPA) and Department of Justice (DOJ) Suit
 Humphrey provided the Board with a summary of recent meetings and
 events related to the AO and DOJ suit. He said the Board should plan to
 review and act on a final version of the stipulated order in the next month.
- 2. Incident at Bates and Moeser Regarding Water Line Break
 Humphrey explained what had transpired following an East Bay
 Municipal Utility District (EBMUD) water line break at Moeser and
 Bates. The water line break caused a failure of the Stege main sewer line
 in the vicinity and consequent overflows and a backup into a home
 downstream on Terrace Drive. Humphrey said that EBMUD was
 responsible for all damages, expenses, and related claims from the backup,
 and he will speak to Mike Wallis at EBMUD about how to make a claim
 to EBMUD.

Humphrey referred the Board to his draft of the LRP agenda and the Board discussed some changes that should be made. Humphrey said he would make changes as discussed at the meeting and bring this back to the Board for review at the next meeting.
